1) Where Is the Value?

We are constantly asking ourselves, where is the value? Which asset classes are on sale, and which are expensive? Reasonable insight comes from the chart below which ranks asset classes from the cheapest (left) to the most expensive (right). Currently, bonds are trading the furthest below their 25-year average valuations, followed by international stocks, then small U.S. stocks and U.S. value stocks. Meanwhile, U.S. large cap stocks, growth stocks and high yield bonds are above their average valuations.

There is no rule that says that assets must return to their 25-year averages, but it adds to our thesis that investors should look to diversify beyond the S&P 500 index and growth stocks. With many bonds and CDs now yielding 5%+, savers and companies with little debt and high cash flows should be beneficiaries in the months and years ahead.

Z-scores based on 25-year average valuation measures*


